

Minutes for SBDM Council Meeting September 27, 2010

Minutes of the Drakes Creek Middle School School Based Decision Making Council's meeting held on Monday, September 27, 2010, in the library of Drakes Creek Middle School, located at 704 Cypress Wood Way, Bowling Green, Kentucky 42104

CALL THE MEETING TO ORDER

The meeting was called to order at 5:31 P.M. by Mr. David Hutchison, Principal.

Members present were: Mr. Hutchison, principal; Jan Casada, teacher representative; Melanie Gentry, teacher representative; Tom Bromer, teacher representative; Linda King, parent representative; and Melanie Lord, parent representative.

A motion was made by Mrs. Casada and seconded by Mr. Bromer to amend the agenda by deleting item 2, "2010/11 School Budget" from the agenda. Motion passed.

Council Members were given a copy of the minutes from the August 23, 2010 meeting. A motion to approve the minutes as read with the addition of Mrs. King being present was made by Mrs. King and seconded by Mrs. Lord. Motion passed.

OLD BUSINESS

Mr. Hutchison reviewed the August Account Analysis Report Summary of Activity Funds with the council. He asked for any questions or concerns. The council discussed funds and expenditures. Mr. Hutchison also discussed the funding support by the board of education for the transition to the new mascot.

NEW BUSINESS

Mrs. Martin facilitated an analysis of the 2009-10 assessment results with the council. Council analyzed the NCLB report and the KCCT Interim Performance Report. The Council reviewed previous results and discussed targets and goals for the upcoming assessment. Mr. Hutchison also reviewed the school's current tier status with NCLB.

Mr. Hutchison shared information about the interviewing process for the Library/Lunchroom Aide position.

Mr. Hutchison discussed the possible need to elect a minority parent and teacher to the council.
