

Rockfield Elementary School

Parental Involvement Policy

The Rockfield Elementary School agrees to implement the following statutory requirements:

At our open house we will conduct our first meeting regarding our Title I programs and offer additional meetings to accommodate parents needing more a more feasible time to meet.

1. 4. Rockfield Elementary School will provide parents of participating children information in a timely manner about Title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet by:

Sharing documentation and information at our open house regarding curriculum and grade level expectations.

1. 5. Rockfield Elementary School will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible by:

Sharing with parents the feedback received and action taken due to the feedback submitted. This may be done in the form of email or other technologies to allow parents to understand that their input was not only received, but also valued.

1. 6. Rockfield Elementary School will provide each parent an individual student report about the performance of their child on the State assessment in at least math, language arts and reading by:

November 1st (After the school receives the information from the state.)

1. 7. Rockfield Elementary School will take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002) by:

The families will be notified in letter form.

1. 8. Rockfield Elementary School will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described in this paragraph --

- the state's academic content standards,
- the state's student academic achievement standards,
- the state and local academic assessments including alternate assessments,
- the requirements of Part A,
- how to monitor their child's progress, and
- how to work with educators:

1. 9. Rockfield Elementary School will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by:

Providing family nights and workshops on such topics throughout the year.

1. 10. Rockfield Elementary School will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:

Joining with PTO, FRYSC and Staff to offer trainings and meetings with parents to keep them informed of our schools' improvement efforts and partner with our parents to make necessary changes.

1. 11. Rockfield Elementary School will, to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with Head Start, Reading First, Early Reading First, Even Start, Home Instruction Programs for Preschool Youngsters, the Parents as Teachers Program, public preschool, and other programs.
1. 12. Rockfield Elementary School will take the following actions to ensure that information related to the school and parent-programs, meetings, and other activities is sent to parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand.
